1. The Roofing Contractor hereby requests Sealoflex to inspect the roofing works and complete a guarantee in favour of the client
2. Sealoflex agrees to inspect (at its discretion) the roofing works and (at its discretion) issue a Guarantee (with such limitations and exclusions as it deems appropriate) duly completed and for the benefit of the Client.
3. In Consideration of the above, Sealoflex and the Roofing Contractor agree to irrevocably bound by the following terms:
4. The Roofing Contractor warrants that the roofing system and materials described above (the Materials) have been installed by the relevant trained operative(s) listed above in a good and workmanlike manner and in accordance with Sealoflex's current specification and guide lines and national standards and Code of Practice.
5. The Roofing Contractor acknowledges that Sealoflex has relied upon the verbal communication of unseen roof build up provided by the Roofing Contractor to Sealoflex as part of the Sealoflex Site Inspection Report of the roofing works
6. For the period of Sealoflex's liability to the Client under the Guarantee which start from the delivery date of Materials, the Roofing Contractors agrees for the full period:
 - a. To investigate all reported roof problems and make repair at his expenses if the problems are due to deviations from specifications or faults of workmanship during the roof installation.
 - b. To perform repairs under this agreement within 30 days written notice by Sealoflex failing which Sealoflex will carry out the repairs and contra charge the amount to the roofing contractor.
 - c. To indemnify Sealoflex for any claims or losses arising under the Guarantee or otherwise which arise from any failure by the Roofing Contractor or from the installation of the Materials not having been carried out in accordance with Sealoflex's recommendations, specifications or with the skill and care expected of an experienced specialist roofing contractor.
 - d. To forward the Guarantee to the Client when paid.
7. The Parties hereby incorporate into this agreement, to the extent that there is no conflict or ambiguity, the Sealoflex terms and conditions of sale, as set out in the Sealoflex price list previously provided to the Roofing Contractor
8. Neither Party shall assign any of it's rights or obligations under this agreement
9. The Parties do not intend that any of the terms of this agreement shall be enforceable by virtue of the Contracts (Right of Third Party) Act 1999 by any person not a party to it.
